

NOTICE OF PUBLIC HEARING

Notice is hereby given that the Shelbyville Board of Zoning Appeals will hold a Public Hearing on **March 10, 2026 at 7:00 PM** in the Common Council Chambers at Shelbyville City Hall, 44 W Washington Street, Shelbyville IN, 46176, to consider four petition(s):

1. **BZA 2026-3** A petition by POET Biorefining for four (4) **Development Standards Variances**, for property located at **2373 W 300 North Shelbyville, IN 46176** to construct additional production space on the south side of their existing complex, and to be granted relief from four development standards, in the *IG - General Industrial* zoning district. The requested variances are from the following sections of the Unified Development Ordinance:
 - A. UDO 5.04 AS-01: *Accessory Structure*: Exceeding the maximum number of allowable structures
 - B. UDO 5.23 HT-01: *Height of Primary and Accessory Structure Height*: Exceeding the maximum height
 - C. UDO 5.46 OS.03.A: *Outdoor Storage Standards*: Allowing the use of gravel/crushed stone in a proposed outdoor storage area

This application may be examined at the office of the Plan Commission of the City of Shelbyville, Indiana in City Hall located at 44 West Washington Street, Shelbyville, Indiana, 46176, Monday through Friday between the hours of 8:00 AM and 4:00 PM.
