Notice is hereby given that the Shelbyville Plan Commission will hold a Public Hearing on **March 23, 2026, at 7:00 pm** in the council chambers at the Shelbyville City Hall Building, 44 West Washington Street, Shelbyville Indiana, 46176 to consider the following petition(s):

1. **PC 2026-02: Rezone Request;** A rezone request by Aaron Callis of parcel # 73-07-19-300-010.000-012 located at 2205 N. Michigan Rd, from R1 - Single Family Residential to IL- Light Industrial zoning district.
2. **PC 2026-03: POET Biorefining Site Development Plan:** A petition for site development plan approval for POET Biorefining for a process and production expansion, located at 2373 W. CR 300 North, Shelbyville IN, located in the IG- General Industrial zoning district.

The application may be examined at the office of the Plan Commission of the City of Shelbyville, Indiana in City Hall located at 44 West Washington Street, Shelbyville, Indiana, 46176, Monday through Friday between the hours of 8:00 AM and 4:00 PM.
